#### From West

- Follow the Massachusetts Turnpike (Interstate 90) East to Exit 111.
- Bear left after the toll (turns into Route 9 West towards Framingham).
- Stay in the right lane. The hotel is the first building on the right.

#### From South

- Take Interstate 95 North to Exit 12B (Interstate 495 North towards Worcester).
- Continue on I-495 North to Exit 58 (Mass. Turnpike/I-90 East) towards Boston.
- Follow the Massachusetts Turnpike (I-90) East to Exit 111.
- Bear left after the toll (turns into Route 9 West towards Framingham).
- Stay in the right lane. The hotel is the first building on the right.

#### From North

- Interstate 495 South to Exit 58, then Massachusetts Turnpike (I-90) East, OR
- Interstate 95 South to Exit 39B to Mass. Turnpike (I-90) West/Massachusetts.
- Either way from Massachusetts Turnpike take Exit 111 and bear left after the toll (turns into Route 9 West towards Framingham).
- Stay in the right lane. The hotel is the first building on the right.
